Board discussed increase amount of storage units in Township and amount of new units in the past few years. Motion by Christian, second by Milburn, to adopt Resolution #2023-10-10c, WHEREAS, storage units or mini storage units are currently permitted within the township subject to the Roscommon Township Ordinance #82 of 2021, which provides for the regulation of storage facilities through a Special Use Permit and Site Plan Review; and WHEREAS, there are currently more than 1,900 approved storage units within Roscommon Township, in which 530 have been approved within the past 18 months, equating to nearly one unit per every two persons based on the 2018 Roscommon Township population; and WHEREAS, approximately 96% of the facilities are located on M-55, the main corridor through Roscommon Township and Houghton Lake; and WHEREAS, 1,900 storage units are in addition to the current outside storage facilities currently permitted; and WHEREAS, the Roscommon Township Board wishes to amend Ordinance #82 of 2021, to provide for an appropriate regulatory approach for addressing the potential impacts of storage units and mini storage units while ensuring productive development of self-storage facilities within Roscommon Township, which may include a cap on the maximum number allowed, building materials required and location. THEREFORE, the Roscommon Township Board hereby temporarily prohibits the establishment of new storage units or mini storage units and the issuance of new permits for self-storage facilities, storage units and mini storage units pending further study by the Roscommon Township Planning Commission, attorney review and an amendment of the Roscommon Township Zoning Ordinance.
